

From the Weed Patch - Alan Rockwood

Saturday, September 2nd, was the final scheduled noxious weed project of the 2023 season. The treatment of upper Beartrack Lakes Trail Canada thistle with a thru-hike from Mount Evans Road to Beartrack Lake to Camp Rock concluded the regular projects. It was a great day for the event. The alpine tundra was in its finest autumn colors. I have never seen a greater abundance of Arctic gentian. I'm pleased to report that only a few Canada thistle plants were found along the upper trail. Most of our treatments were directed at the area just above the wilderness boundary – commonly known as the "Wilderness Burn." This day was a good representation of our overall progress during the past few years. Many sites are progressing toward eradication, and others have pockets still requiring intense treatment. I want to personally thank all of you for generously giving your time and energy to preserve the native wilderness habitat this season and in seasons past. I hope you feel proud of what we are accomplishing. There is still much to be done.

In many respects, the end of one weed eradication season is the beginning of the next. Our final reports to financial supporters lay the foundation for the next grant cycle. The reports must genuinely convey our successes and understanding of the work to be done. The financial support we receive for the Invasive Species Program is excellent, but the most critical resource for the task is the corps of caring and committed volunteers. Without your help, there is no weed program. It is not lip service when I say thank you to the volunteers. The experience you gain this season and apply to the next is a critical asset.

I say thank you, but perhaps it is best coming from someone within our partner, the US Forest Service, who is also in the trenches fighting for native wilderness habitats.

Ever Wonder What It Takes To Run FOMELC Financially?

As a volunteer organization, FOMELC has had to evolve and change the funding model as time has gone on. When FOMELC was initially started in 2005, a seed grant from the Wilderness Society for \$25,000 helped launch the Friends as the newest group to help steward the important wilderness lands of Mt. Evans and Lost Creek. In addition to the seed grant, FOMELC entered what is known as a cost-share agreement with the South Platte, Clear Creek, and South Park ranger districts, as these lands cross over multiple national forests. The essence of a cost-share agreement is that as a volunteer organization doing work on behalf of the Forest Service, each year we agree to complete certain levels of work in agreement with the Forest Service, and in return we receive a grant. Over the years, these amounts have ranged from \$1,500 to as much as \$5,000. Those funds dried up in 2019, but we were fortunate enough to get a cost-share agreement in place this year for the first time since 2019 as funds were made available by the USFS in the amount of \$12,000.

In addition to the cost-share agreement, FOMELC had traditionally relied on member dues as well, but the Board voted to do away with member dues starting in 2019, wanting to provide a way for more people to participate without financial obligation and realizing that volunteer time was a significant source of payment in itself. Finally, FOMELC has increasingly competed for and received significant restricted grants to enhance our field programs. This is a trend that is likely to continue in the future. But as "restricted grants", they can only be used for projects with little or no funding for organizational expenses. At the same time, they tend to put pressure on those expenses - recruiting volunteers, communication platforms, training, uniforms, and insurance. These grants we receive require "matches" from volunteer time and it is a competitive process with other grant applicants. The more volunteers who are involved the projects, the more hours they contribute, the better chance we have of being funded.

While our expenses are not exorbitant by most standards, FOMELC has had to turn to other funding sources and grants to help with ongoing expenses. The reality is that FOMELC does need to rely on the community in which we do our work, which is why you will see our end-of-year fundraising appeal over the coming months.

Revenues and Expenses

Though a non-profit organization, FOMELC still operates as a business, and as any business, we take in revenues and incur expenses to operate the business. At the beginning of the year, the Board meets to discuss and approve a budget for the year, which includes estimates for our revenues and both fixed and variable expenses that we anticipate for running various programs. Based on how revenues come in through the year, we make adjustments to variable expenses and decide where we might have to make cuts or can expand what we do. Let's take a deeper look at some of the numbers:

In 2022, we took in \$23,516 in revenue, with more than half of that coming from state weed grants that gets passed directly to Foothills Vegetation for a lot of the spraying work and in support of the weed work led by Alan and his weed teams. Our annual fundraising appeal last year brought in over \$2,700, so thank you for your donations! Additionally, for the last few years, we have also benefitted from a grant from the Platte Canyon Community Partnership which brought in \$4,000 last year. Finally, we received over \$3,800 in corporate donations as well as over \$1,800 from donations through the year not tied to the annual campaign.

Looking at the expense side of the equation, we incurred expenses of \$16,067, leaving a surplus of about \$7,449. A few years back, we intentionally cut down on some of our expenses to be prepared for economic shifts and to ensure we have a healthy cushion in the bank. We do have some set, fixed expenses which include items for running the business, such as our subscription to Constant Contact (\$600/year), Insurance (\$1,400/year), and most importantly our work with Foothills Vegetation, who takes care of a lot of weed spraying for our grants.

With regard to variable expenses, in 2022 we focused on items such as new hats and shirts, member events, and all-hands days, and various other expenses that help support our mission and our members, but don't necessarily cover the day-to-day running of the organization. For many of the grants we secure, we actually have to incur some costs to make them happen, such as additional insurance or project-based expenses, which go to these variable expense items as well. These are the areas where the Board makes adjustments to the budget, which we did for 2023 with some conservative adjustments to our variable expenses.

However, people are getting back on the trails and we were able to adjust our budgeting for 2023 to allow for more projects and activities. As previously mentioned, we are excited that the cost-share agreement and associated funds are again available from the Forest Service, though we never know how long that might last. And, while we do have money in the bank, we have gotten to a place where we can't rely on cost-share agreement grants or some of the traditional sources of funding and we are looking to build on the great foundation we have as an organization. And though we can't do all of the great work we do without our volunteers on the ground, we hope in addition that you can add FOMELC to your annual giving considerations.


